**Notes**

1. A "YES" with an asterisk indicates an election to fill the office for the remainder of the term.
2. Contests for Byrdstown municipal offices and School Board offices are nonpartisan.
3. Historically, the Pickett County Republican Party has chosen to hold a primary for local offices, and the Pickett County Democratic Party has chosen to hold a caucus for local offices. This may change for future election cycles.
4. Judicial retention questions, referendums, and possible special election dates are not shown.
5. The next regular election for the district 13 judicial offices will be in 2030.
